## **## 1. Introduction**

Welcome to the Reiki & Meditation Retreat, held from 21<sup>st</sup> to 26<sup>th</sup> November in Dahab, Egypt. By participating in this retreat, you agree to comply with and be bound by the following terms and conditions. Please read them carefully.

## **## 2. Booking and Payment**

### **### 2.1 Reservation**

- A deposit of 30% of the total retreat cost is required to secure your booking.
- The remaining balance must be paid in full according to the schedule set out on the booking form.

### **### 2.2 Payment Methods**

- Payments can be made via bank transfer, Vodafone Cash or InstaPay as per the instructions on the Booking Form. All transaction fees are the responsibility of the participant.

## **## 3. Cancellation and Refunds**

### **### 3.1 Cancellation by Participant**

- The deposit is non-refundable.
- Further payments may be refunded in extraordinary circumstances via discussion with the organisers.

### **### 3.2 Cancellation by Organizer**

- In the unlikely event that the retreat is cancelled by the organiser, all payments received will be fully refunded after 21<sup>st</sup> September.
